### A.3. General indicators of scientific production quality

I have two six-year research period bonuses (sexenio) recognised in 2017 (research) and 2020 (transfer). I have been listed among the top world scientists in 2020 Stanford Ranking. I have 106 publications, including 69 articles published in JCR journals. My articles received 1166 citations on the Web of Science (average of 27.1 per article). Among my publications, 39 are included in Q1 JCR journals (8 in the top 10%). My JCR h-index is 20 and my Google Scholar h-index is 40 (5024 citations). Our book titled "Protecting Children against Bullying and its Consequences" was recommended as reading in the UK House of Commons for the anti-bullying policy debate. I am Visiting Scholar in the Institute of Criminology, University of Cambridge and a member of Wolfson College, University of Cambridge. I am a consultant of Cambridge Assessment focused on positive school climate. Editor in Chief of Aggression and Violent Behavior.

#### Part B. BRIEF CURRICULUM

Izabela Zych, PhD is an Associate Professor in Psychology in the University of Cordoba (Spain). She is a Visiting Scholar in the Institute of Criminology, Cambridge University and a member of Wolfson College, Cambridge University. She is a member of LAECOVI research team at the University of Cordoba and an affiliated member of Violence Research Centre, University of Cambridge. Her main research interest focuses on developmental prevention of antisocial behaviour, bullying and cyberbullying, with particular attention to personal and contextual risk and protective factors. She has directed different research projects mostly focused on prevention of antisocial behaviour online and offline. She has been an invited speaker in international conferences across the world and published dozens of journal articles related to antisocial behavior in high impact journals. Her postgraduate and undergraduate teaching and PhD supervision are mostly related to youth violence. She is a consultant of Cambridge Assessment International Education and Editor-in-Chief of Aggression and Violent Behavior.
