Part B. CV SUMMARY (max. 3500 characters, including spaces)

My research career combines the specialization in contemporary American fiction, begun in my PhD dissertation, with an openness to new themes and perspectives (South African fiction, modernist



narrative, trauma studies, communitarian theories). Among the merits that show my position as researcher specialized in the field of contemporary American fiction, I can mention the invitations received to take part in international seminars and conferences (Aalborg, Denmark, 2006; Osnabrück, Germany, 2008; Munich, Germay, 2010), as well as the publications in this field.

My research has been published in 2 monographs as single author, 2 collective volumes as coeditor, 2 critical editions, 20 articles in specialized journals, 19 books chapters, 7 contributions to conference proceedings, 6 reviews and several translations of literary and academic texts. I have taken part in 39 conferences and have given 4 lectures as invited speaker. I have been part of the organizing committee of 6 conferences, including the 42nd AEDEAN Conference. In the recent past, I have reinforced my cooperation with other researchers through the four research projects on fiction and communitarian theories (2010-2012, 2013-2015, 2017-2019, 2020-2022), whose main outcomes are the collective volumes edited (the first two in Palgrave and Routledge, the third forthcoming in Bloomsbury) and co-authored papers with other researchers.

My trajectory has been characterized by a constant increase in the internationalization of my production and the supervision and training of younger researchers. My recent research has a clear international projection, in academic journals (*EJES, Arizona Quarterly, English Studies, Critique, JNT*) and SPI indexed publishing houses (Bloomsbury, Palgrave, Routledge, Continuum, Winter). The second aspect is evinced in the MA theses (34) and PhD theses (1) supervised in the last decade, as well as in my responsibilities as Director of the MA Program in Advanced English Studies at the University of Córdoba and Head of the PAIDI research team "HUM-682 – English and Related Literatures".

My research has been clearly influenced by critical theory and deconstruction. I attended the Master's seminars given by J. Hillis Miller and Jacques Derrida at the University of California, Irvine, while on a FPU scholarship. Their influence, especially in relation to contemporary theories on community and ethics, has been determinant in my trajectory at an individual level, and has also served as theoretical basis for the three research projects in which I have been involved, in the second one as Main Researcher. My participation in these projects has had as a result several publications (1 monograph, 2 co-edited volumes, 22 articles and book chapters) focused on the representation of communities in fiction. This background in literary theory and critical theory has been reinforced in the postdoctoral period of my career through research conducted at the School of Criticism and Theory, at Cornell University (2009) and the Summer Course in Narrative Studies organized by the University of Aalborg (2018), or through seminars and conferences in which I have had the opportunity of learning from authors such as J. Hillis Miller (Córdoba, 2006), Derek Attridge (Córdoba, 2014; Granada 2018), Jacques Rancière (Granada, 2014), Antonio Negri (Valencia, 2015) or Nicholas Royle (Granada 2018).
